MOTION TO EXPEDITE APPEAL

Pursuant to Local Rule 12(c), Appellant Hospira, Inc. ("Hospira") respectfully moves to expedite proceedings in the above appeal. Hospira's complaint challenges the August 18, 2014 decision of Appellee U.S. Food and Drug Administration ("FDA") in Docket No. FDA-2014-N-0087 which led to the immediate approval of generic versions of Hospira's brand-name drug Precedex®. The U.S. District Court for the District of Maryland (Hazel, J.) granted Hospira's motion temporary restraining order on August 19, following an emergency hearing. (ECF Nos. 19-20). A week later, on August 26, the district court denied intervenor-defendant Mylan Institutional LLC's motion to reconsider the temporary restraining order in total, while amending the order in part. (ECF No. 75). The district court consolidated the preliminary injunction motion with a final decision on the merits, and issued a memorandum opinion and final order on September 5. (ECF Nos. 122-123). As the procedural history of this case demonstrates, there are substantial interests at stake in need of expeditious resolution.

The appeal can be resolved on the existing record, the record before the agency, which was filed with the district court. Hospira respectfully requests that the Court schedule oral argument on this matter given the substantial matters and interests at stake.
