Upon consideration of the motions to dismiss for lack of jurisdiction, the response thereto, and the replies; and the motion for limited remand, the response thereto, and the reply, it is

ORDERED that the motions to dismiss be granted. The district court order remanding to the FDA is not an appealable final order, because it anticipates further agency action not limited to merely "ministerial" proceedings. <u>See Pueblo of Sandia v.</u> <u>Babbitt</u>, 231 F.3d 878, 880 (D.C. Cir. 2000). It is

FURTHER ORDERED that the motion for limited remand be dismissed as moot.
